Minutes of the Regular Meeting of the Cape May County Library Commission held on Wednesday, December 10, 2025 at 1:30pm, in the Board Room of the Cape May County Library in Cape May Court House, NJ.

1. Mrs. Henderson called the meeting to order and announced it was being held in accordance with the Open Public Meetings Act.
2. The minutes of the regular meeting of November 19, 2025 were presented for review and approval. Mrs. Henderson made a motion to approve the minutes, which Mr. Mastrangelo seconded. The motion passed unanimously.
3. Orsini presented the bills for the month of November for review and approval for payment. The list of bills was discussed. Mrs. Henderson made a motion to approve the bills for payment, which Mr. Mastrangelo seconded. The motion passed unanimously.
4. Under old business:
 - a. Orsini gave an update on the Dennis Twp. lendIT project.
 - b. Orsini also reported that the new Bookmobile is scheduled to be delivered on 12/19.
5. Under new business:
 - a. Orsini reported on the November 2025 programming statistics and noted there were 4,403 participants in the month of November. Notable November events included Dinosaurs After Dark, Mr. Boom Boom, Zoophoria NJ, an embroidery holiday wreath workshop, Exploring Abstraction, and the TLC's Make Something for the Holidays.
 - b. The annual Library Commission holiday luncheon was held on 12/3.
 - c. Orsini reported that the library participated in Christmas in Court House on 12/5, and offered a festive hot cocoa bar, bake sale benefiting the Cape May Animal shelter, and festive crafts in the TLC.
 - d. Resolution December 2025 #1, New Hires, was introduced. Mrs. Henderson made a motion to accept the resolution, which Mr. Mastrangelo seconded. The resolution passed unanimously.
 - e. Resolution December 2025 #2, Separations, was introduced. Mr. Mastrangelo made a motion to accept the resolution, which Mrs. Henderson seconded. The resolution passed unanimously.
 - f. Resolution December 2025 #3, LOAs, was introduced. Mrs. Henderson made a motion to accept the resolution, which Mr. Mastrangelo seconded. The resolution passed unanimously.
 - g. Resolution December 2025 #4, 2026 Library Commission Meeting Schedule, was introduced. Mrs. Henderson made a motion to accept the resolution, which Mr. Mastrangelo seconded. The resolution passed unanimously.
 - h. Resolution December 2025 #5, 2026 Non-Resident Card Fee, was introduced. Mrs. Henderson made a motion to accept the resolution, which Mr. Mastrangelo seconded. The resolution passed unanimously.
