Cassie – I know Gary has been out of the office today, so I am going to go ahead and send over.

The 23-24 premium was \$26,000-\$2,734 (Ohio Plan Advantage Credit) for a total paid of \$23,266. The renewal is up \$1,568 from last year. The property is up \$7-8,503, library materials \$237,119, inland marine \$10,000 and edp \$21,031 for inflation.

Your expiring cyber coverage is with Lloyds and was \$3,522. I have a quote from Lloyd’s for \$3,833 and American Trust at \$3,538. Gary will be recommending that you consider taking the coverage with American Trust this year. I will send the cyber information in a second email.

Underwriting is asking for an appraisal on the Cinderella Painting that we have scheduled for a value of \$10,000.
