Section A - Steel Shelving

Item: A.1 Qty: (7)

Description: Wall mount shelving sections, each to measure 90"H and will be constructed using new Aurora wall mount column strips. In each shelving section, LDA will install (3) existing 10"D or 12"D adjustable shelves. No corner filler will be utilized. This will allow space for book trucks to be parked below the adjustable shelves.

Item: A.2 Qty: (2)

Description: Single face sections of existing steel shelving, 90"H X 10"D X 36"W. Sections to be relocated from another area of the Annex.

Item: A.3 Qty: (18)

Description: Single face Aurora shelving sections, 90"H X 10/10"D X 36"W. Each section equipped with (1) 10"D integral back base shelf, (6) 10"D integral back adjustable shelves and (7) integral back sliding wire book supports. No end panels or steel tops have been included with this item. LDA will provide and install (1) new steel corner filler, to complete the installation.

Item: A.4 Qty: (19)

Description: Double face Aurora shelving sections, 90"H X 10/24"D X 36"W. Each section equipped with (1) 24"D integral back base shelf, (12) 10"D integral back adjustable shelves and (14) integral back sliding wire book supports. No end panels or steel tops have been included with this item.

Item: B.1 Qty: (2)

Description: "Gibraltar Series" adjustable height staff tables from The Worden Company, each to measure 30"D X 72"L. Height adjustment for this table to range from 26-1/2"H to 39-3/4"H.
