SCOPE OF WORK:

Johnson-Laux Construction Ohio (JLCO) hereby proposes to furnish all supervision, labor, materials, and equipment necessary to complete the above referenced project as detailed in the plans, specifications, and what is clarified below.

This change order consists of miscellaneous electrical work as directed in the field by CRCPL. The list is as follows:

- Repair UF cable and supply conduit for future sleeves underground
- Removed exterior wall packs and cameras for siding contractor and reinstalled after completion
- Relocated exterior camera on front door overhang
- Added (3) receptacles in new wall in IT Room
- Added data receptacles in Offices 136 & 138 & Lobby 133
- Added (1) receptacle in Closet 135
- Added (2) receptacles in Office 141; (1) in conduit and (1) in wall
- Added (5) receptacles in Outreach Office, (2) in conduit and (3) in walls
- Re-routed exterior wiring and installed (2) LED wall-mount fixtures
- Added light in Closet by Restrooms
- Added (2) emergency exit combo fixtures in Room 143
- Added data receptacle in Room 143
- Added power for Door in Room 143
- Installed 300 lf of Cat6 cable with pull string
- Includes credit for deletion of Board Room floor boxes
- Includes credit for deletion of pop-up receptables in counter-top

GENERAL DETAILS & NOTES:

1. JLCO shall maintain clean work areas. Site shall be cleaned every day at the completion of work.
2. Parking will be made available for JLCO by the Owner and JLCO shall coordinate all parking with the Owner prior to the beginning of work.
3. JLCO shall coordinate inspections as required.
4. JLCO is responsible for protection of all surfaces including those not in the scope of work from construction dust, debris or damage during construction up until final acceptance. The methods of protection are plastic, paper, sealing doors or windows, etc.
