

# Change Order Request #1

#### **Chillicothe & Ross County Public Library Renovation**

CRCPL Annex 140 S. Paint St. Chillicothe, OH 45601

#### SCOPE OF WORK:

Johnson-Laux Construction Ohio (JLCO) hereby proposes to furnish all supervision, labor, materials, and equipment necessary to complete the above referenced project as detailed in the plans, specifications, and what is clarified below.

- 1. Hydrovac excavate (2) 1' wide x 20' long x 3' deep areas for turndown footers at concrete steps.
- 2. Provide and install #4 rebar per drawings.
- 3. Form (1) set of 20' wide concrete steps with (7) risers.
- 4. Pour concrete steps with 4000psi concrete.
- 5. Strip forms and rub out faces of steps.
- 6. Form and pour (1) 10'-6" wide x 20' long x 4" thick section of concrete sidewalk at the bottom of steps.
- 7. Core drill holes for new handrail.
- 8. Install owner provided handrail.
- 9. Replace a section of 4" ductile sch40 PVC pipe approx. 20 lf.

#### **GENERAL DETAILS & NOTES:**

- 1. JLCO shall maintain clean work areas. Site shall be cleaned every day at the completion of work.
- 2. Parking will be made available for JLCO by the Owner and JLCO shall coordinate all parking with the Owner prior to the beginning of work.
- 3. JLCO shall coordinate inspections as required.
- 4. JLCO is responsible for protection of all surfaces including those not in the scope of work from construction dust, debris or damage during construction up until final acceptance. The methods of protection are plastic, paper, sealing doors or windows, etc.
- 5. Staging area for project related materials provided by owner.
- 6. Area to be free of personnel and equipment as not to delay work schedule.
- 7. Work to be performed at **normal working hours at Prevailing Wage rates.**

#### SCOPE OF WORK:

Johnson-Laux Construction Ohio (JLCO) hereby proposes to furnish all supervision, labor, materials, and equipment necessary to complete the above referenced project as detailed in the plans, specifications, and what is clarified below.

#### Break Room 114 Modification:

- 1. Remove existing East wall of Breakroom 114 and reinstall 6" above existing ceiling grid.
- 2. Remove one side of drywall on North wall of Breakroom 114 and install insulation. Reinstall drywall, finish, prime and paint.
- 3. Build new wall, running East and West in existing Breakroom 114 to separate room.
  - a. 3-5/8" metal studs and 5/8" drywall to be used.
- 4. Fur out existing West (CMU) wall of separated room with 1-5/8" studs to 6" above ceiling grid.
- 5. All new and existing walls to receive new batt insulation.
- 6. Install drywall on furred out wall.
- 7. Finish, sand and prep walls for paint.
- 8. Paint all walls in separated room.
- 9. Rework existing ceiling grid and tiles to accommodate new wall, furred out wall and heightening existing walls.
- 10. Provide and install (1) Mitsubishi thermostat and wire to provide heating and cooling to the newly separated area. The existing unit will be utilized but will need to be on its own thermostat.
- 11. Program new thermostat for newly separated area and test/balance.
- 12. Reprogram existing thermostat and unit for existing Breakroom 114.
- 13. Provide and install (3) new electrical receptacles and (3) new data drops (chases and boxes only) for newly separated area.
- 14. Provide and install new door and frame for newly separated area.
  - a. This opening (114) was previously going to utilize a relocated existing door and frame.
- 15. Relocate existing door access controls from existing door 114 to utility closet.
- 16. Provide and install F/A device in newly separated area if required.
