Forsyth County Public Library Board of Trustees Minutes from September 18, 2023 Meeting

The Forsyth County Public Library Board of Trustees held its September meeting at the Cumming Library on September 18, 2023. Present were Board members Kristin Morrissey (Chair), Mary Helen McGruder, Lisa Stortzum, Kathy Thomas, and Christy Winters. Also present were Anna Lyle (Director), Holly Barfield, Ann Decherd, Jeff Fisher, Lorraine Lane, and Nikki Watkins. Sabrina Kerns with the *Forsyth County News* was also present.

I. Call Meeting to Order

Kristin Morrissey called the meeting to order at 5:30 p.m.

II. Adoption of Agenda

There was a motion by Kristin Morrissey and a second by Mary Helen McGruder to adopt the Agenda without amendments. Motion carried unanimously, with all Board members present.

There was a motion by Lisa Stortzum and a second by Mary Helen McGruder to approve the Photography and Filming policy, effective September 19, 2023. Motion carried unanimously, with all Board members present.

6. Security Camera Policy

Holly Barfield, IT and Facilities Manager, provided an update on the Denmark Library project.

8. Proposed Fiscal Year 2024 budget adjustments

There was a motion by Christy Winters and a second by Mary Helen McGruder to increase Donations revenue and Materials expenses by \$600.00 to reflect a donation from the Lanier-Forsyth Rotary Club for books in honor of Rotary speakers. Motion carried unanimously, with all Board members present.

There was a motion by Mary Helen McGruder and a second by Lisa Stortzum to increase Donations revenue and Materials expenses by \$1,405.00 to reflect donations made in memory of Mary Ann McCarthy and Ashok Barre. Motion carried unanimously, with all Board members present.

There was a motion by Lisa Stortzum and a second by Kathy Thomas to decrease State revenue and Operations expenses by \$5,357.00 to reflect a decrease in Post E-Rate Technology Reimbursements. Motion carried unanimously, with all Board members present.

There was a motion by Kathy Thomas and a second by Kristin Morrissey to increase State revenue and Operations expenses by \$56,344.60 to reflect the FY2024 LibTech grant. Motion carried unanimously, with all Board members present.

9. Financial Reports

Nikki Watkins, HR and Finance Manager, presented the FY2024 financial report for the period ending August 31, 2023.
