**The Board voted unanimously to approve an increase in State revenue and Operations expenses by \$25.00 to reflect FCPL's additional share of a GPLS grant from the Sandra Dunagan Deal Center for Early Language and Literacy.**

**The Board voted unanimously to approve an increase in Donations revenue and Operations expenses by \$5,000.00 to reflect a grant from the Rotary Club of Forsyth County for summer reading books and prizes.**
