A RESOLUTION ADOPTING THE ESTIMATE OF THE 2026 TAX LEVY FOR THE FREMONT PUBLIC LIBRARY DISTRICT,  
LAKE COUNTY ILLINOIS

WHEREAS, the Fremont Public Library District (the "District") is a non-home rule government organized and operating under the authority of the Illinois Constitution and the Public Library District Act of 1991, 75 ILCS 16 et seq.;

WHEREAS, the Trustees of the District are required by the Public Library District Act of 1991, 75 ILCS 16/30-85, to prepare and enact a budget and appropriation ordinance pursuant to the Illinois Municipal Budget Law 50 ILCS 220/1, et seq., and a Tax Levy Ordinance pursuant to the Property Tax Code, 35 ILCS 200;

WHEREAS, in anticipation of the passage of the Tax Levy Ordinance and pursuant to 35 ILCS 200/18- 55, et seq. (The Truth in Taxation Act) it is in the best interest of the District to estimate the annual tax levy.

WHEREAS, the proposed corporate and special purpose property taxes to be levied for 2026 are \$5,800,000.00. This represents an 5.12% increase over the previous year.

NOW, THEREFORE, BE IT ORDAINED BY THE Board of Trustees of the Fremont Public Library District, Lake County, Illinois, as follows:

Section 1. Recitals. The foregoing Recitals are incorporated as substantive portions hereof as though set forth herein.

Section 2. The board hereby finds that there is need to hold a hearing subject to the Truth in Taxation Act as the proposed increase in the annual tax levy is greater than 105% of the previous year's levy.

Section 3. This Resolution shall be in full force and effect from and after its passage and approval as required by law.
