Approval of Agenda

James Green made a motion to approve the consent agenda. Gerri Schroder seconded the motion. The vote was unanimous.

Bette Silverman made a motion to approve the consent agenda. Jennifer Andricopulos seconded the motion. The vote was unanimous.

Director's Report

Possible Board discussion of the Director's report or various staff reports highlighting various administrative and staff activities since the last meeting.

Marcie Smedley announced Candace Kingsley recently retired at 15 years with Henderson Libraries. Marcie Smedley thanked her for her service and wished her well in her retirement.

Update on the progress of shifting the team to support the new strategic plan was given. All coordinator (management level) positions have been filled. Marcie Smedley ran through the updated list of new leadership:

- Customer Service Coordinator for the Green Valley Library: Vivian Tufano
- · Customer Service Coordinator for the West Henderson Library: Shakita Kirkland
- · Two customer Service Coordinators for the Paseo Verde Library: Christina Terriquez and Marshá Wells
- · Customer Service Coordinator for the Gibson Library: Leona Vittum-Jones

All management positions are in place. Positions for specialized programming and collections have been interviewed and notifications will soon be made. What is left is the customer service team and most of those will are being transitioned from their existing position into customer service because they serve in the public facing capacities. An opportunity is given to identify a preference for location. Then any

holes will be filled by part-time employees transitioning into full-time employees. Any remaining openings will be opened up for applications from outside the library district, which will bring new people into the organization to support this effort. Positions yet to be filled include the People and Culture Coordinator (the application process for this position just closed with 88 applicants, narrowed down to 8 for Zoom interviews). The job posting for the Assistant IT Manager is still being finalized. The leadership team is in place and ready to go, which is exciting. All other changes and shifting are on track to be in position for the transition date in August. The strategic plan is moving forward. This has required a lot of patience from our team as each piece needed to be completed before moving forward. Marcie Smedley said it is going well and she looks forward to working with the leadership team and the entire team as Henderson Libraries moves into the future.

The One Book One Henderson community read is underway. The book is The Henna Artist by Alka Joshi. There will be a book talk and signing next week, July 24th at 6:30 p.m. at the Henderson Multigenerational Center. Last year's crowd was too large for the Paseo Verde Library Reading Room; the partnership with the City of Henderson allows us to expand the availability to attend the event. Programs leading up to the event include: The Art of Henna Tattoos, featuring Chetna Sutaria who furnished henna tattoos to patrons; Take home spice kit; a diya [do it yourself] craft which involved shaping or molding pots out of clay, a traditional material for diya lamps; introduction to Indian classical music with Sandip Thanki and he will be playing as people come into the event next week; and a lot of book discussion groups — at the library and out in the community. It's been a great opportunity to bring the community together and to have a cultural experience where one connects with others. Marcie Smedley thanked the committee for all of the hard work put into developing the great programs for the Henderson community to experience. Everyone is looking forward to the author visit next week; hopefully some of the Board will be able to attend.

The Gibson Library is featuring the All of Us Journey exhibit today and tomorrow. It's a program of the National Institute of Health. There is a big bus that includes interactive exhibits, video games, and attendees have the option to enroll in the All of Us Journey research program which is part of the National Institute of Health that has evolved one of the most robust health databases in history. Participation in the program allows researchers to see how biology, lifestyle and environment affect health and disease. As a host location, we had the opportunity to apply for a grant that enabled the district to build and curate an e-book and e-audio book health and wellness collection through Libby. This is a great opportunity to promote health literacy in the community.

Angela Brommel thanked Marcie Smedley for the update on the restructuring, saying she was excited to hear about future opportunities, more growth and learning more about it in phases.

New Business

Discussion and possible Board action regarding the Five-Year Capital Improvement Plan

Tawana Keels said the Nevada Department of Taxation requires Henderson Libraries to file a five-year capital improvement plan by August 1st each year. A copy has been provided; it is required to align with the budget that is already approved. The five-year capital improvement plan is broken down by 3 funds:

- The General Fund, additional library materials and equipment, funding through the General Revenue, \$1,450,000.
- The Contributions & Grants Special Revenue Fund, additional library materials and equipment, funding through grants and donations, \$125,000.
- The Capital Construction Fund, building improvements, funding through the General Revenue, \$500,000.

Angela Brommel asked for public comment. There was none.

James Green made a motion to approve the Five-Year Capital Improvement Plan. Gerri Schroder seconded the motion. The vote was unanimous.
