

**QUEENS BOROUGH PUBLIC LIBRARY

- How the Contest Works: Each participating Library branch will have a receptacle filled with fifty (50) pre-selected quotes from the seven Harry Potter books, printed on individual slips of paper. During the Contest Period, interested participants (“Contestant(s)”) will have one opportunity, on a first come first serve basis, to pull out a slip at random from the jar. The Contestant will then have one (1) minute to correctly identify from which Harry Potter book the quote was taken, without consulting any external sources, including smartphones, computers, or other people. If a Contestant correctly identifies the quote, he or she will have her name added to a pool of names that will be entered into a drawing for certain prizes, as described herein. Successful Contestants will be asked to provide their name and an email address, which will be used solely for the purpose of contacting the Contestant if he or she is

a winner of the subsequent Drawing. Contestants' email addresses will not be used for any other purpose, and will not be shared with any third parties.

4. Drawing Time and Location: The names of all successful Contestants will be entered into a drawing, which will take place on Friday, August 31, 2018 at 3pm (the "Drawing"). The Drawing will be livestreamed on the Library's facebook.com account.
5. Winner Selection and Notification: Three names will be selected at random by the Library from the names of successful Contestants (the "Winners"). The first name drawn will receive the Third Prize, the second will receive the Second Prize, and the third will receive the First Prize. The three Winners will be notified via e-mail within three (3) days of the Drawing. The Library shall have no liability for any Winner's failure to receive such notice due to spam, junk e-mail or other security settings, or the provision of incorrect or otherwise non-functioning contact information. In the event that a Winner cannot be contacted, is ineligible, or fails to claim the prize within seven (7) days from the time award notification was sent, the Prize may be forfeited and an alternate Winner selected. Receipt by a Winner of a Prize is conditioned upon compliance with any and all federal, state, and local laws and regulations. Any violation of the Rules by a Winner will result in that Winner's disqualification from the Contest and all privileges as a Winner will be immediately terminated.
6. Prizes: The Winners will receive the following prizes (the "Prize(s)"):
 - a. First Prize – Special illustrated editions of the first three Harry Potter
 - b. Second Prize – DVD set of all Harry Potter movies
 - c. Third Prize – Three Harry Potter 20th Anniversary T-shirts
7. No cash or other Prize substitution shall be permitted, except at the Library's discretion. The Prizes may not be transferred or assigned to others. Any and all Prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of the Winners. Acceptance by any Winner of a Prize constitutes permission for the Library to use that Winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law. If any Winner is under the age of 18, he or she must have a permission form for such usage signed by his or her guardian before receiving a Prize. Such permission form will be provided by the Library upon notification to the Winner.
8. Odds: The odds of winning depend on the number of eligible entries received.
9. Disclaimer: The Prizes shall be awarded "as is," without warranty of any kind, express or implied, including, without limitation, any warranty of merchantability or suitability for a particular purpose. The Library reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Contest should non-authorized human intervention, fraud, or other cause beyond the Library's control corrupt or affect the administration, security, fairness, or

proper conduct of the Contest. In such case, the Library may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by the Library. The Library reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or otherwise violates these Rules.

10. Release: By participating in this Contest, You agree to be fully unconditionally bound by the the Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of the Library as final and binding as they relate to this Contest. By participating in this Contest you further agree to release and hold harmless the Library and its trustees, officers, employees, affiliates, and assigns from and against any and all claims, demands, or causes of action that may arise in connection with Your participation in the Contest and/or your acceptance, possession, use, or misuse of any Prize or any portion thereof.
